## About the Designation Order Form

<b>When to Use the Designation Form:</b>	Use the Designation Order form when the preneed property contract is paid in full and the owner wishes to designate an interment right.
<b>Purpose of the Designation Form</b>	The Designation Order form is used in advance of need to designate the right of interment of an individual in a specified grave, crypt or niche at Rose Hills Memorial Park in Whittier, California.
<b>Instructions for Using the Designation Form</b>	<ul style="list-style-type: none"><li>• The specified cemetery property must be paid in full.</li><li>• All owners (and spouses) must sign the document. Signatures must be notarized by a notary public or witnessed by a Rose Hills Title Administrative representative.</li><li>• A Designee Letter will be mailed to the designated individual(s) to inform them of their rights.</li><li>• The letter states the name of the cemetery property owner who designated the individual for interment and it states the specific space for the designation.</li><li>• Permits the designee to be interred in the specified grave, crypt or niche.</li><li>• Designation does not give the designee any rights to the ownership of the space.</li><li>• The Designation can be cancelled or rescinded at any time without the designees consent or knowledge.</li><li>• The cemetery property owner(s) continue to control all rights to the designated space, including the right to change or rescind designations without the designees consent or knowledge.</li><li>• The cemetery property owner(s) also controls the placement of markers.</li><li>• If the cemetery property owner(s) signs a new Designation Order, it cancels or rescinds any prior designations.</li><li>• If the cemetery property owner(s) changes title of the designated grave it cancels or rescinds the designation.</li><li>• If the cemetery property owner(s) are deceased the designation is still valid.</li><li>• There is no fee to designate an individual for interment in a specified grave, crypt or niche at Rose Hills Memorial Park in Whittier, California.</li><li>• If the cemetery property owner(s) are requesting to make a double designation (two designees in the same grave) the double depth or double interment fees must be paid in full before the Designation Order may be executed. If this fee has been paid, contact the Title Admin and Records dept. for the form. If the fees have not been paid, contact your sales counselor.</li></ul>
